The Solution

PMP Gateway is a managed service and comprehensive connectivity and clinical decision support solution that enables access to data, analytics, tools, and resources from PDMPs within care team workflows in real-time, at the point of care, to improve patient safety and outcomes. It interoperates seamlessly via native integrations with all leading EHR and pharmacy management platforms; PMP InterConnect, which facilitates access to multi-state data; as well as NarxCare, the premier platform for addressing substance use disorder (SUD).

For care teams, PMP Gateway enables efficient access to a patient's PDMP information and more within the workflow of the EHR. Clinicians previously needed to log into separate websites to retrieve a patient's PDMP information from the state database and then cross-reference that data with a patient's health information in disparate systems. PMP Gateway saves physicians, on average, two to five minutes per patient reviewing a patient's PDMP report.
